CONCLUSION

Because of this, Christy turns from a frightened person into a person who is proud of himself. Christy becomes proud of himself because the villagers admire him. Besides that he notices that the women give a great attention to him, especially Widow Quin and Pegeen Mike.

Yet, this pride turns into denial when Christy finds out that his father is still alive. It is difficult for him to accept the reality that actually his father is not dead. Christy denies this reality because he does not want to lose the villagers' admiration and Pegeen's affection. Besides that, he does not want the villagers to think that he has lied to them. He asks Widow Quin's help in denying the reality about his father. In this case, Christy finds protection from Widow Quin.

In order to gain the villagers' admiration and Pegeen's affection, Christy tries to kill his father again in front of the villagers. Unfortunately, the villagers consider that there is a big difference between an heroic story and a brutal action. They can not accept Christy's action toward his father. **So,** they want to hand him over to the police.
